FAMILIARIZATION PROCESS FOR NEW INDEPENDENT DIRECTORS

The Company conducts an introductory familiarization program when a new Independent Director joins the Board of the Company. The induction comprises a detailed overview of the business verticals of the Company and meetings with other directors/ business heads/ senior leadership team, and with the Chairman, at which time; the Independent Director is familiarized with various aspects of the Company’s business verticals including the industries in which such businesses operate. At the same time, he/ she is also familiarized with the roles, rights and responsibilities in the Company.

CONTINUOUS FAMILIARIZATION PROCESS FOR REGULAR INDEPENDENT DIRECTORS

The Company will familiarize the Independent Directors on its Board, with detailed presentations on the Company and its operations and business plans and the model of its respective businesses.

In addition to such quarterly familiarization made at Board Meetings, in case, the requirement arises, the Company also schedules additional dedicated Board Meetings at which specific aspects of the Company’s business plans and future outlook will be reviewed and discussed.
